

Michael Gorman's Tribute to Local Philanthropist Frank Cann

Still Serving, Chris Manning & the American Legion

Haverhill native Chris Manning is the current Commander of American Legion Post 4 in Haverhill, Massachusetts. Chris grew up in Haverhill, one of twelve children, his three brothers all served in the US Military. His dad served in

the South Pacific during World War II, as a Machinist Mate First Class. His older brother served in the US Navy in Vietnam, as part of the carrier-based air war against the Communists. His younger brother served in both the US Navy and US Air Force. Of his eighty-six nieces and nephews, one niece served over twenty years in the US Air Force,

retiring as a Chief Master Sergeant. Chief Master Sergeant is the highest Air Force enlisted rank.

Chris Manning, served during the height of Cold War. Our interview, started with a discussion on his military service, a very modest man, he turned it towards his service to his fellow Veterans. Working within the American Legion, Chris spends most of his free time helping Veterans.

Millions of Americans served during the Cold War, 1946 to 1991. The United States and the Soviet Union were the key players, as they were the two superpowers of the world. Both nations lost troops during the Cold War, which many civilians think was not a real war. Very few, if any US Military Veterans take this stand on Cold War service. Many incidents occurred, that could have turned out tragic, if quick solutions were not made, by politicians and military leaders on both sides of the Iron Curtain. Leaders, both from United States and the Soviet Union saved the world from a nuclear war.

The United States lost around three hundred and eighty-two military members during the so called, Cold War. Some of the casualties came through direct fire enemy action, particularly in Korea after the 1953 Armistice. Other



Military members lost their lives, not as the result of engagements, but from "incidents" between the Communist Bloc and the US Military. Historians find this number to be fluid, as incidents such as the attack on the USS Liberty AGTR-5 and the capture of the USS Pueblo AGER-2, produced casualties. For the US Navy sailor killed on the USS Pueblo, and the thirty-four US Navy sailors who died on the USS Liberty, the Cold War, was not so "Cold."

A graduate of Whittier Technical High School, Chris served in the US Army as an engineer, out of Fort Dix, NJ. He also traveled widely on the US Army rifle team, shooting his M-14 rifle at targets from 50 yards to 600 yards away. Serving from 1978-1984, he left the US Army as a Sargent. After leaving the US

Thank You Lawrence General Hospital!

Last month, a team of doctors, nurses, and other medical professionals at Lawrence General Hospital feverishly worked around the clock for more than a week to save the life and stabilize the vital signs of our Valley Patriot publisher Tom Duggan.

While we are holding the details of why and how this all happened for a full story in next month's newspaper, we could not let this edition go to print without showing our profound gratitude for the multiple miracles these brave men and women were able to pull off over the first nine days Duggan struggled in a coma and on a ventilator in the intensive care unit of the LGH.

Tom, himself wanted us to report that once he was transferred out of ICU and went into a regular room (in the Hamlet building) of LGH, the nurses and doctors continued to provide what he called "a far superior level of care and professionalism" than he ever expected.

"At first, I thought they were giving me the VIP treatment because I thought, maybe they knew who I was, or that I work in the media, so they were stepping up their game," Duggan said. "But, after being in the hospital for more than 21 days I came to realize that they treated everyone this way - and that made me feel really good about the professional care the patients at Lawrence General were getting on a daily basis."

As a side note, Duggan said that a large part of his recovery was the quality of the food at LGH.

"Before all this happened, I used to eat one big meal a day, but the food here was so damn good it was like getting restaurant food for every meal. I actually looked forward to the three daily meals I was getting. Every day it was extreme comfort food for me no matter what the menu item was, because the quality of the food was really something special."

"I know that sounds a little crazy to hear that hospital food was that good, but I can say unequivocally that the quality of the food at LGH was a really big part of why I recovered faster than my family expected, and why I went to rehab in much better shape than anyone expected."

We at the Valley Patriot prayed very hard during those early days Duggan's life was in jeopardy and we worked even harder to keep this information off of social media and away from the public, until he was out of the woods and in recovery mode. Most people - even among his close friends and family - didn't even know Duggan was ill until the day he posted he was being discharged from the hospital and on his way to rehab.

We now want Tom's friends and loyal readers to know that we did this on purpose because these were Tom's

wishes. As most of you who regularly read this newspaper already know, there are some very powerful, very corrupt politicians, judges, and businessmen in the Merrimack Valley who have taken every opportunity they could to try and have this newspaper shut down to silence Duggan from exposing their graft and illegal activities.

For those people to find out early on that Duggan was struggling to survive would have provided the perfect opportunity to start another boycott, or manufacture another bogus scandal, to try and get advertisers to stop supporting the paper. And with Tom unable to fight off such attacks because of his coma, it could have been the end of this newspaper. We could not let that happen.

Bridging the Digital Divide: The Affordable Connectivity Program

If you or someone you know might qualify for this program, I encourage you to explore its benefits and sign up today. I am committed to continuing these workshops in partnership with Housing Authorities in Haverhill, Lawrence, Methuen, and beyond, as together, we strive for a more inclusive and connected future.

Why the Affordable Connectivity



Program Matters

Winning the New Cold War Against China

Chinese President Xi Jinping has mobilized his totalitarian regime against the United States and her allies, with a strategy that has all the hallmarks of a new Cold War. If leadership in Washington is blind to this new reality, we must vote for new leaders in 2024.

I am fearful that Biden and his negotiating team will repeat the same colossal mistakes of FDR, who trusted Stalin's word that he would not seek a sphere of influence in Europe after World War II. The fact that White House envoy John Kerry couldn't even acknowledge that Xi is a dictator during a recent congressional hearing, leads me to believe that a bold course of action reminiscent of Reagan's Cold War strategy is paramount to our national security.

Reagan won that contest of good versus evil because he recognized that the Soviet Union's vision of humanity was rotten to the core. That the foundation could collapse if sufficient external pressure was applied. Reagan's modernization and rebuilding of America's military might, bolstered by our inherent wealth and technological superiority, bankrupted any Soviet efforts to match our forces and liberated Eastern Europe.

Our nation's complacency during hostile Chinese military incursions across Asia must cease immediately. Taiwan, the Philippines, Japan, Australia, and South Korea have been witnessing missile tests, illegal military bases, naval and aerial confrontations and other provocative actions by either China or her puppet state in North Korea.

Meanwhile, the Chinese Communist Party (CCP) and state-owned businesses have purchased farmland near our military installations in the United States. The CCP served as the lowest qualified bidder to construct new railcars for the T system in Boston, which have experienced numerous technical problems since delivery. And although some federal and state government entities have banned their workers from using TikTok due to data collection concerns, the rest of our population, especially our children, are vulnerable to privacy issues. Why is Congress and the President allowing these questionable transactions to continue?

Imagine during the height of the Cold War, the voters found out that the Soviets purchased land near our air bases, constructed our subways over American companies and had an undue programming influence on our children. They would throw the bums out of office who allowed such a mess. Where is the outrage in 2023?

The CCP still engages in massive intellectual property theft, unfairly subsidizes their companies at the expense of foreign competition and sends spies into our research facilities and universities. In fact, Xi could invoke an anti-espionage law at any time—which theoretically empowers the communists to target the sensitive data of any foreign firms operating in China.

As leaders of the free world, the United States can never fully trust Xi, but we can achieve peace through a new mutual defense alliance of Asian democracies, similar to the now defunct Southeast Asia Treaty Organization, and enforceable international treaties.

Furthermore, we must decouple

our economy from theirs before it is too late. Trump already started the transformation to confront this new Cold War on multiple fronts. He applied punitive tariffs against China, ushered in a new and robust North American free trade agreement (USMCA), encouraged companies to relocate back to America through corporate tax reform, opened our natural resources and substantially increased military spending. As a direct result, domestic manufacturing has boomed, products are being sourced once more in our hemisphere and we are curtailing our supply chains from bureaucratic entanglements in China.

COVID-19 revealed the sinister authoritarian mentality of Xi, who refused to let WHO teams into the hot zone of Wuhan for months during a global crisis. Xi has created a disturbing cult of personality, akin to Mao and Stalin. He has consolidated power through his exclusive, uncontested authority, weakening the central committee and removing key senior members. He has rewritten communist dogma in his image, and instituted a philosophy that the nation must endure sacrifices to achieve victory against the West. Instead of promoting a consumer and entrepreneurial class, he is assigning the newest generation to a life of unwanted industrial drudgery. Economic liberalization has not translated into capitalism, free enterprise, and freedom.

The last time there was such a stark consolidation of power in China, it tragically occurred under Mao. Approximately 80 million people were killed during the Great Leap Forward—twice the estimated deaths under the Stalin regime. Is the world prepared for a similar course of action under Xi?

Given the systemic 'reeducation' and persecution of the Uyghurs Muslim minority, the Orwellian lockdown of millions during COVID and the continued threats against perceived enemies abroad, how can Xi be identified as an honest broker of peace?

Xi props up the repressive socialist regimes of Venezuela, Cuba, and North Korea. He gives aid and comfort to Russia and Iran, whose actions have caused the direct deaths of Americans and Syrian civilians.

However, China's centralization of power and its authoritarian policies have created a paper tiger ripe for potential revolution. The youth unemployment rate is at least 20% and could be as high as 50%. China is so corrupt with statistics that it has stopped even publishing data on youth employment and consumer activity. China's overall debt-to-GDP ratio is fast approaching 300%. A dangerous commercial and housing construction bubble has developed, which could engulf 30% of the economy. Defaults on loans are worsening by the day. And Chinese workers placed much of their savings into these dubious ventures. The population is declining, and because of the disastrous one child policy, China's elderly population will soon explode.

We must expand our military superiority in the Pacific aligned with our Asian allies, curtail trade incentives with Xi, encourage companies to return jobs domestically and pass sweeping reforms in Congress to restrict any further CCP activities on the home front. Peace through Strength will prevail once again over the party of concessions and ineffectual moderation. ◊

State Auditor DiZoglio Makes Sure There Are No Unfunded Local Mandates

Within the Office of the State Auditor is the Division of Local Mandates (DLM), a critical resource for our cities and towns.

DLM was established in 1980 under the property tax limit initiative known as Proposition 2 1/2. The DLM team assists in determining whether state laws, rules, and regulations fall within the scope of the Local Mandate Law, which was created to address local officials' concerns about the State Legislature enacting laws requiring local action without providing the necessary funds to cover the associated costs.

Although many state mandates are crafted to address important statewide concerns, the Local Mandate Law ensures that unfunded mandates do not pose unfair financial or administrative challenges for local governments. If a city or town believes that a state law, regulation, or rule is imposed upon them without adequate funding, they can request a mandate determination. If it is determined that an unfunded mandate exists, DLM provides an analysis of the municipal financial impact.

The Massachusetts General Laws allow DLM to examine any state law or regulation that has a significant local cost impact, regardless of whether it is an unfunded mandate. Because of this law, DLM also releases reports known

as "municipal impact studies" or "6B reports" that examine various aspects of state law affecting municipal finances, which include recommendations that are designed to make government work better. Over the years, DLM has issued reports on many topics, including public infrastructure, regional school districts and municipal police in-service training, educational services for students in foster care and state care, and property tax exemptions for senior citizens.

DLM also plays a role in election cost certifications by ensuring that all 351 communities are timely surveyed to accurately determine election costs eligible for reimbursement. Cost certification ensures that millions of dollars are returned to cities and towns to cover election-related expenses. Based on this certification, the Secretary of the Commonwealth provides funding to cities and towns to offset expenses.

Phil Thibault Hasn't Learned Lesson in Dracut

EYE ON DRACUT

If you think Dracut's most rejected perennial candidate—nine-time loser Phil Thibault—couldn't be any more bitter than he already is about being the town's monumental loser, think again. This time, Dracut's self-proclaimed perpetual victim Phil Thibault and his fruit loop friends are lamenting because he wasn't appointed to a town board, again. Phil Thibault, the guy who has come up short in eight elections for selectman (and who lost an election for housing authority, too), apparently thought he'd be perfect to fill the open seat... on the school committee.

Let's put Phil Thibault's electoral history in historical perspective: He's choked in selectmen's races in 2005, 2007, 2015, 2016, 2018, 2020, 2021 and 2022, after getting his butt kicked in that housing authority election. He's lost electoral contests against all five sitting selectmen, including three head-to-head matchups against Selectman Joe DiRocco. In other words, Phil Thibault has lost as many elections as Hillary Clinton, Stacey Abrams and Beto O'Rourke combined, plus two more. In his own mind, however, that makes Phil Thibault fully qualified to serve on the school committee, apparently.

Phil Thibault had perhaps the shortest candidacy for school committee in town history: He announced he was in the race

and then a nanosecond later he was out. In between, Phil Thibault apparently realized he was unable to muster five votes from the Board of Selectmen and School Committee. (Members of those two boards ended up unanimously appointing Rob Sheppard, a guy who actually ran for school committee last year and finished third in that five-way race behind winners Allison Volpe and Dr. Linda Trouville.)

Make no mistake about it: Phil Thibault's inability to secure that school committee appointment is a game changer; he's finally lost the support of some who previously wasted a lot of political capital, time, money, effort on a guy who continues to lose and lose and lose and lose and lose and lose and lose. It was bound to happen eventually because Phil Thibault's not just the likely loser in every contest, he's the proven loser and proven to be Dracut's biggest loser.

Meanwhile, one of the main reasons Phil Thibault can't win anything is that he's surrounded himself with some of the most nasty and negative voices in our town, those who constantly try to tear down Dracut. Just ask current School Committee Chairman Allison Volpe, who's been under attack from Phil Thibault's friends in print, on cable tv

and on social media since he dropped out of the running.

On September 12, an author on What's Happening Dracut who did not identify themselves went after Volpe on their Facebook page, alleging she broke the school committee bylaws by failing to hold a reorganization when Sheppard was appointed to the board. Most of those who bothered to respond defended Volpe. One person called the page's posters "armchair quarterbacks" who try "to create controversy and drama because they think they have all the answers." Another called their posts "ridiculous" and "sensationalist." Yet another person said it was "much ado about nothing," considering the other issues facing the school committee and town.

Volpe also responded, explaining that a reorganization is done after the annual town election, not when a member is appointed to fill a vacancy. She added that she'd be happy to hold a reorganization if that is the will of the committee. (Where was the outcry for a reorganization when Dr. Linda Trouville was appointed to fill Betsy Murphy's unexpired term? Cue the hypocritical crickets.)

Volpe, of course, was attacked by Phil Thibault who accused her of not providing Sheppard with the same rights



and privileges of other members. "to (sic) be dismissive of his membership as appointed does no one service," Phil Thibault posted.

Volpe wasn't tolerating any of it and responded to Phil Thibault directly, tagging him in her comment on the original post. "Phil Thibault, no one is dismissing Mr. Rob Sheppard. As you will see he will be afforded the same rights as all members. I am dismissing the nonsense this page likes to spout to increase clicks."

With "friends" like Phil Thibault, Allison Volpe doesn't need any enemies, apparently.

Anyway, here's what the Lowell Sun Here's what the Lowell Sun said when Phil Thibault lost his selectman's race in 2020. "It just might be that in Thibault's

My Name is Michael Gorman and I am the Founder of the non-profit organization - The Movement Family, which is designed for anyone looking for a second family in life. One that may be seeking love, guidance, and support or really just looking to give back to the community and make a difference in the world.

I'm honored to speak about someone that means so much.

It all started on September 23, 2020, when FH Cann Associates sponsored the TMF Dinner when it was at the vacant lot on 2 South Broadway in Lawrence, MA.

I didn't know Frank personally at this time. He was actually following Tom Duggan's posts on Facebook. He became very inspired by TMF's work in the community and wanted his company FH Cann to sponsor a dinner.

On January 26, 2021, I was honored to be asked to be the guest speaker at the Exchange Club Meeting and with COVID at this time, the meeting was through zoom. So, I spoke to the Exchange Club, from 6-7pm.

Once the zoom call ended, at 7:01pm my phone starts ringing, I look at the phone, and it's Frank Cann. He and I haven't had too many personal conversations at this point, but he shared how inspired he became by this talk.

He then shared, "I had all my family members in the living room listening to you speak."

He asked me one specific question. "What's your goal and vision from here?"

I told Frank, "I don't think we can become anymore of a grassroots program than we are."

Now, if anyone has done non-profit paperwork before, I had no idea where to begin. I was naive. Frank took me under his wing and helped me with the entire 501(c)3 paperwork, where it finally became a non-profit organization. I was so happy and grateful that I asked Frank to be a board member and Treasurer of TMF.

A few things that stick out to me about Frank.

His heart, kindness, determination. He is 100% a go getter. If he wants something, he is going to do all he can to make it happen. But most importantly, what sticks out to me most about Frank has been his guidance. His teaching moments are ones I will cherish for the rest of my life.

Just to share a few things that Frank did for TMF; Frank helped us obtain our first website to help make us more professional. Frank helped TMF get its first PO box and helped create the idea of having a 10-year anniversary event for TMF to show all the hard work that we have done throughout the years where we had 250 people show up at the Claddagh function room. Frank sponsored the IT gentleman and DJ for the evening.

Or was it Frank taking time out of his day to take me out to eat at the Fireside Restaurant, or breakfast at Ellie's to talk about life?

He would always reiterate to me, "I'll always be here for you Michael. I really believe in your vision and care about you as a person."

One of his proudest achievements was the partnership between the Boston Celtics, FH Cann, and TMF. We call it "The Big 3" It was so special that Frank was able to give these young TMF members who have never been to a game in their life, to not only watch the game, but Frank got us a suite so TMF

Frank was also a season ticket holder for the New England Patriots and got TMF Members to their first NFL football game in their life.

Ironically, Frank and I were both inducted into the Methuen High School Hall of Fame Alumni on March 24, 2023 (See photo page one) and I can't express to you how special it was to have someone I look up to - a role model who has taken me under his wing - on that stage with me getting inducted into the Methuen High School Hall of Fame on the same night.

My Dad always told me, "appreciate the people that help pave the way." That

phrase means more to me right now because Frank helped pave the way.

My Mom used to always have this quote on the fridge that said, "People may forget what you said, and forget what you did, but people will never forget how you made them feel."

When Frank was in that room or when Frank took me out to eat to talk about life, he made me feel so comfortable, he gave me nothing but confidence, and always believed in me.

I am very thankful to have gotten to know Frank, his wife Sheri, his daughter Kara, his son Justin, and his son-in-law Ernesto.

Rest in Peace my friend Frank Cann. You will be missed. ♦

case, familiarity breeds more contempt than content. Buoyed by the backing of several town influencers – including former selectmen – one would have thought it was his election to lose, which he did. It could also be payback for the decision by that screening panel he ran not to put interim – now permanent – Town Manager Ann Vandal on the list of finalists for that position."

Bingo! It wasn't Phil Thibault's job to fire the interim town manager and that's exactly what he tried to do by not including Vandal on the short list. Thankfully, Phil Thibault wasn't ultimately involved in the final hiring decision back in 2020 because selectmen scrapped the tarnished search process, got rid of him and kept Vandal.

Since that time, Phil Thibault continues to spew toxicity about our town, elected officials, private citizens, and business owners on his bestie John Zimini's unwatchable cable TV show, a local version of Wayne's World with a similar level of maturity and cast of characters. Phil Thibault's television appearances are wicked dull and hilariously sad, just like him. During the 2022 town election, Phil Thibault was calling Dracut sleepy.

In 2021, Phil Thibault said our town was starting to rot. What's sleepy is Phil Thibault's campaigns and what's rotten is the way he talks about Dracut.

Why would voters want to elect Phil Thibault, a guy who hates our town so much? Thankfully, Dracut isn't buying what Phil Thibault has been selling. In fact, voters keep sending him the same message—" thanks, but no thanks"—but Phil Thibault doesn't want to hear it, apparently.

Regardless, Phil Thibault thinks he's the smartest guy in the room, no matter who's in the room. Just ask him. Speaking of which, Phil Thibault always wants to be in the room, apparently. He's been lurking around town government for decades, keeping the seats warm on a bunch of town boards. If you've gotten Phil Thibault's self-centered political mailings throughout the years, you've seen the extensive list, but not a single accomplishment or new idea to benefit Dracut. Like George Costanza, Phil Thibault can't wait to tell anyone who will listen that he's an architect. You'd be hard pressed to meet a more self-absorbed politician; the thing Phil Thibault likes to talk about the most is

himself.

When there's an opening on any town board these days, and not just the school committee, Phil Thibault rushes his application over to town hall right away. In a town of 34,000 people, Phil Thibault always thinks he's the most qualified person for the job. The reality is that Dracut doesn't need Phil Thibault to sit on another board, we need someone— anyone—other than him! He's stale, his lack of ideas is stale, and so are his not-ready-for-primetime pals.

Phil Thibault has been very angry ever since he was rejected by the Board of Selectmen for the newly created at-large seat on the Zoning Bylaw Review Committee last December. The board majority cited conflict of interest, as Phil Thibault is an architect who conducts business in town. Instead of reflecting inward, Phil Thibault lashed out. But the truth hurts: In 2016, Phil Thibault resigned from the Planning Board after speaking with the state's Ethics Commission and then he went on his buddy Warren Shaw's AM radio program to talk about it. Shaw's sidekick Shawn Ashe posted the audio recording on his Dracut Forum blog. (<https://www.dracutforum.com/index.php/2016/08/28/phil-thibault-resigns-from-planning-board/>)

Phil Thibault should look in the mirror, especially if he wants to talk about ethics and conflicts of interest. Or read the Lowell Sun. In October of 2020, the newspaper exposed some of Phil Thibault's completely unethical and self-serving behavior at DATV.

"Imagine if Phil Thibault had been elected to the Dracut Board of Selectmen. Even though the Dracut Access Cable Television board of directors, on which Thibault serves, is technically not a government body, Thibault apparently thought there was nothing improper with landing a \$10,000 contract to help design DATV's new studio, as Thibault is an architect."

Phil Thibault is always good for one thing: a laugh. Phil Thibault's short-lived school committee candidacy is no exception. Sadly, however, Phil Thibault keeps failing to learn his lesson. Class, and class clown, dismissed.

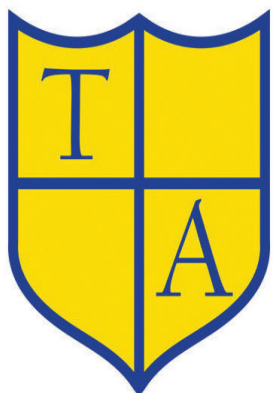

Emotional Eating/Finding Balance with Food

Kane has felt stressed out lately! He finds himself running to food to feel better! He has been sneaking food when nobody is around, hiding the wrappers in his house, and plotting and planning how to get more! Yesterday he almost stole his human's whole pizza. Although the food is great in the moment, it doesn't really make him feel better. In fact, it doesn't really sooth his stress. It feels rather out of balance. So, Kane went to a counselor, a library, and did research late at night online and found out he is an emotional eater! Kane decided he would like to have a healthy relationship with food so here is his journey.

Kane learned that many people have a complex relationship with food. According to a 2013 article from the American Psychological Association named "Stress and Eating" (Are teens Adopting Adults' Stress habits?), 38% of adults say they have overeaten foods in the past month due to stress. These individuals reported they do so because it helps them distract from their worries. The article reports half of these adults (49%) report engaging in these behaviors weekly or more. Some also site habit as a reason it continues. So

Kane learned he was not alone. I guess it was good for him to look at this and be honest about where he is with his relationship with food, and where he would like to be.

His counselor suggested he make a list of how his day was going. It is important to keep a log of whether there was an emotional eating episode or not and what emotions triggered the episode. So, Kane got to work on this. He discovered he was mad yesterday morning when his sister Ruby went out with his humans, and he was left alone. He felt lonely and ignored. At the time he didn't know she was going to the vet. No thank you to that thought Kane. Anyway, right away he tried to open the bread drawer to see if he could find some crackers. Maybe feeling mad, lonely, and ignored would lessen if he found crackers or even those lame dog cookies his human buys. Kane told his counselor this was hard to look at in general. He felt judged by himself and the whole



thing felt kind of raw even though being honest with himself was the way to go.

Kane kept his food and emotions log and learned that foods were not good or bad. In fact, all foods in moderation creates a healthy mindset towards food. He chuckled at thinking that twinkles don't rob banks. However, being healthy means eating each meal, and two snacks to keep his metabolism moving and his body satisfied so he doesn't confuse physical hunger with emotional hunger and the most important element was not judging yourself. It is important for Kane to think of his journey as fact finding and trying different approaches to see what works. Kane learned that recovery from food challenges is never

a straight line. Instead of shaming himself, Kane will say it's me Kane, I struggle with this, but I will get back on track the next meal or snack. Forward movement is movement.

Kane learned from his counselor and reading that black and white thinking is an enemy to his recovery. Saying negative things like you are weak, you messed up again, you can't do this just zaps the positive energy you could use for change. What about today I learned I can't have a whole cake on my counter, or bringing my lunch to work is best for me. Thinking of the change as caring for yourself in a positive way. Being kind during the transitions.

So, in review Kane learned the following points that have helped him develop a positive relationship with food.

Keep an emotion and food log.

Enjoy all foods, with treats in moderation.

Approach your journey with kindness and compassion towards yourself.

Notice black and white (all or nothing thinking) and make room for the gray instead, room to explore what happened and what you could do differently next time.

As for Kane, he discovered sometimes he just enjoys being a bit naughty. So instead of stealing food and using it to manage his emotions, he hides phones, keys, and papers on his humans. He even steals laundry. You should see them looking for it. He would blame Ruby, but they know she never does anything wrong.

Happy balanced eating to all. Food is meant to be enjoyed.

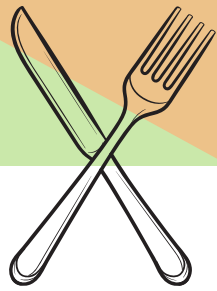

I occasionally like to say, tongue in cheek, that the Constitution of the United States was never ratified in Dracut.

All the rights and privileges afforded by that document cease to have validity and relevance within the town borders. I find it humorous and laugh, until it is true. There is a mindset among some in political office that the public need not concern themselves with the complicated and complex workings of government. The unwashed masses just cannot comprehend the needs of government. Although, it was my understanding that the government should understand the needs of the public.

Take for instance, the latest kerfuffle over the fulfillment of an elected official's unexpired term due to a resignation. Joe Wilkie, former School Committee Chairman, resigned recently with nine months left to his term.

I am sure the resignation was a difficult decision to make with a brief time left. There is a difficult balance that must be made by people dedicated themselves to public service. We wish Mr. Wilkie the best and thank him for his service to the Town of Dracut and the School Committee. The resignation sets in motion not only a "process," but Massachusetts Law for the appointment of a replacement member. For Dracut, "we don't need no stinkin' laws!"

The law would have the Chair of the affected board notify the Board of Selectman within thirty days of the resignation and the need for appointment. The appointment in this instance would be made by both the affected committee, the School Committee, and the Board of Selectmen. This needs to happen one week after the notice is posted. There is another scenario for Dracut.

The notification is the same for the resignation, at least we start from the same point. The "process" set by the Selectmen Chair is to post a notice of interest for ten days. There is another divergence that is not written but imposed by Alison Genest, Chair of the Board of Selectmen. She wishes to have the School Committee provide only a recommendation to the Board of Selectmen for the appointment. A recommendation much like in other instances, has been ignored by the Troika, Genest, DiRocco, and Kopcinski, holding power. The appointment is scheduled for the next Board of Selectmen meeting. I hope the School Committee pushes back and demands their rightful place to vote on the appointment. There is also the concern that the names of the potential appointees will not be made public. A secret public official if you may.

Why should Alison Genest stop there?

She has inserted herself into every facet of government in Dracut under the guise of being Selectmen Board Chair. She created an ad hoc committee and made herself chair while being and an abutter to the property the ad hoc committee was overseeing.

Alison Genest removed a competent member of the Zoning Bylaw Review Committee and inserted herself; devoid of any zoning or planning experience. She has cast a pall of dread over many Town boards, commissions, and employees. She will not be deterred, and



there is still more.

The Town Charter was crafted by a Town Charter Commission and adopted in 1985 at the Annual Town Meeting. There were eleven members of the public elected to the office of Charter Commission. There were some sweeping changes: a Town Manager, an appointed Planning Board, and the creation of a Permanent Building Committee to name but a few. The Town Charter called for a review at ten-year intervals. The first review was in 2005, only twenty years behind schedule. There were no significant changes made, I suspect, because no one desired an in-depth review. The next review was made in 2015 by the Board of Selectmen. The most notable change made was for the qualifications required to be appointed Town Manager. The qualifications were diminished, and standards lowered. Another Charter review is being discussed by the Board of Selectmen, and Alison Genest does not want your involvement.

The Town of Dracut's "constitution" will not be decided by the consent of the governed. Department Heads are initially reviewing the Charter. There has been some debate as to bringing in a consultant, the Collins Center from Boston, to help shepherd the Selectmen through the process for compliance with the State of Massachusetts laws and regulations.

The Collins Center assisted in the search for a replacement Town Manager when Former Manager Duggan resigned. You can imagine who did not like independent thought then and will not tolerate it now. Alison Genest gesturing to her laptop at a public meeting said, "we don't need a consultant, we have these." What a world we live in, when a thirty-minute Google search is presumed to be the equivalent of thirty years of experience. It was said at the Selectmen meeting that after the Department Heads, Town Staff and the Selectmen made their review the townspeople would be "permitted to make comments."

Hopefully, Selectmen Archinski or Santiago-Hutchings will be making a motion to create an elected Charter Commission for the review. They both have faith in the citizenry of Dracut to govern themselves and determine how they wish to be governed, unlike Chair Alison Genest. Imagine Alison Genest writing the Constitution of the United States these days. "You the People..." ◊

BENEATH THE SURFACE WITH PAUL MURANO

Forgive 77 Times?

Sunday's gospel reading was about forgiveness. A main theme was that since God forgives us, we should never refuse to forgive others. Forgiveness, however, is a bit complex and commonly misunderstood. What does it mean to forgive? Let's go beneath the surface.

First, forgiveness seems to have two related meanings found in Scripture and common usage: 1) forgiveness offered, and 2) forgiveness received. In the first sense, God in Christ has forgiven the whole world. In the second sense, not all are 'forgiven' since not all accept it.

Also, forgiveness is an act of the will, not an emotion. A victim can forgive while still being deeply hurt by their offender or while sustaining a righteous anger. Forgiveness is a decision to offer the offender good will, despite the latter's bad behavior.

Is this possible? Probably not by our own nature, which tends to seek vengeance for injury. But it's very possible with divine grace. The old adage "To err is human, to forgive divine" is not off base.

But what if the offender is not sorry?

There are two reasons that harm-doers may have no remorse: a) They genuinely believe they did nothing wrong. If this is from invincible ignorance due to immaturity or mental illness, for example, they incur no guilt. b) They don't care. In this case, when forgiveness is offered it is not received.

This means there can be forgiveness without reconciliation.

There's a reason the Catholic sacrament in which Christ forgives sins is nicknamed the sacrament of reconciliation. If a person sins mortally, God may forgive him in the



first sense of the word above, but without contrition the sinner does not receive it, and remains estranged from God. Dying in this state means an eternity in Hell.

Further, forgiveness and even reconciliation between people do not necessarily mean

a restoration of the relationship as it was. The injustice(s) incurred may have altered things to the point that it may be most prudent to love one's neighbor from a distance.

Lastly, forgiveness does not necessarily mean retracting all punishment. If punishment will lead the sinner to remorse and repentance, it's a good thing. Salvation depends on our contrition and repentance.

While the ideal of forgiveness is for the offender to express remorse, seek forgiveness, receive it, be reconciled, and have the relationship restored – in a fallen world perfection is not always realized. Nevertheless, it is our moral duty to forgive those who harm us, and this means willing their good – which ultimately means their salvation – despite any residual hurt or righteous anger that may linger.

God offers all people forgiveness even though some may not accept it and remain dead in their sins. We must do the same: "Love your enemies and pray for those who persecute you... be perfect as your heavenly Father is perfect" (Mt 5:44, 48).

Who Will Enforce the Law In Salisbury?

This was originally published by Tom Duggan on February 26, 2020. This project is now apparently moving forward.

As of right now, it looks like the state Administration's Seaport Economic Council gave Salisbury a nearly \$1 million grant in 2017 to build the 625 foot boardwalk on Ocean Front South, so that in just a few years the Town of Salisbury would consider allowing this public seaside boardwalk to be connected to the deck of the "Big Block" proposed 235-unit Oceanfront condominium complex that are surely to become apartments.

The Big Block Development Group consists of Capolupo, Nabhan and Mulcahy families who initially planned on constructing this project in 2017.

Most importantly, the Town of Salisbury officials were well aware that this proposed "BIG BLOCK" project violates the 1980 State Executive Order 181 Barrier Beaches. That executive order was enacted to strengthen the protection of barrier beaches in Massachusetts, and orders/directs all relevant state agencies to adopt 7 policies regarding mitigating

future storm damage to its barrier beach areas.

Also, in 1985 Salisbury officials signed a US Environmental Protection Agency/State of Massachusetts Sewer Special Grant condition agreeing [that Salisbury] shall prohibit connections to the sewerage system from any new development built within a 100-year flood plain, wetland, or barrier beach (Salisbury Beach).

Coastal Zone Management (CZM) and Mass Disaster Recovery Team has raised concerns to the Town of Salisbury that the barrier beach appears to be eroding rapidly in the beach center.

CZM has informed Town Manager Neil Harrington and Town Planner Lisa Pearson that "Based on its coastal setting, CZM is concerned that the potential for storm damage impacts to development in this area is significant and very real, and that inappropriate development will adversely affect the barrier beach resource area's ability to respond to increased wind and wave energy associated with storms."

Is there anyone out there willing to force the rogue Town of Salisbury



to start following the law? Or will town officials just continue to get away with doing whatever they want to satisfy their money man Wayne Capalupo? It seems only the voters of Salisbury are capable of doing that.

Maybe they will show up at the next Planning Board public hearing at Colchester Room at Town Hall on Feb. 12th and put a stop to it. Given how they voted in the last election, however, I'm not holding my breath.

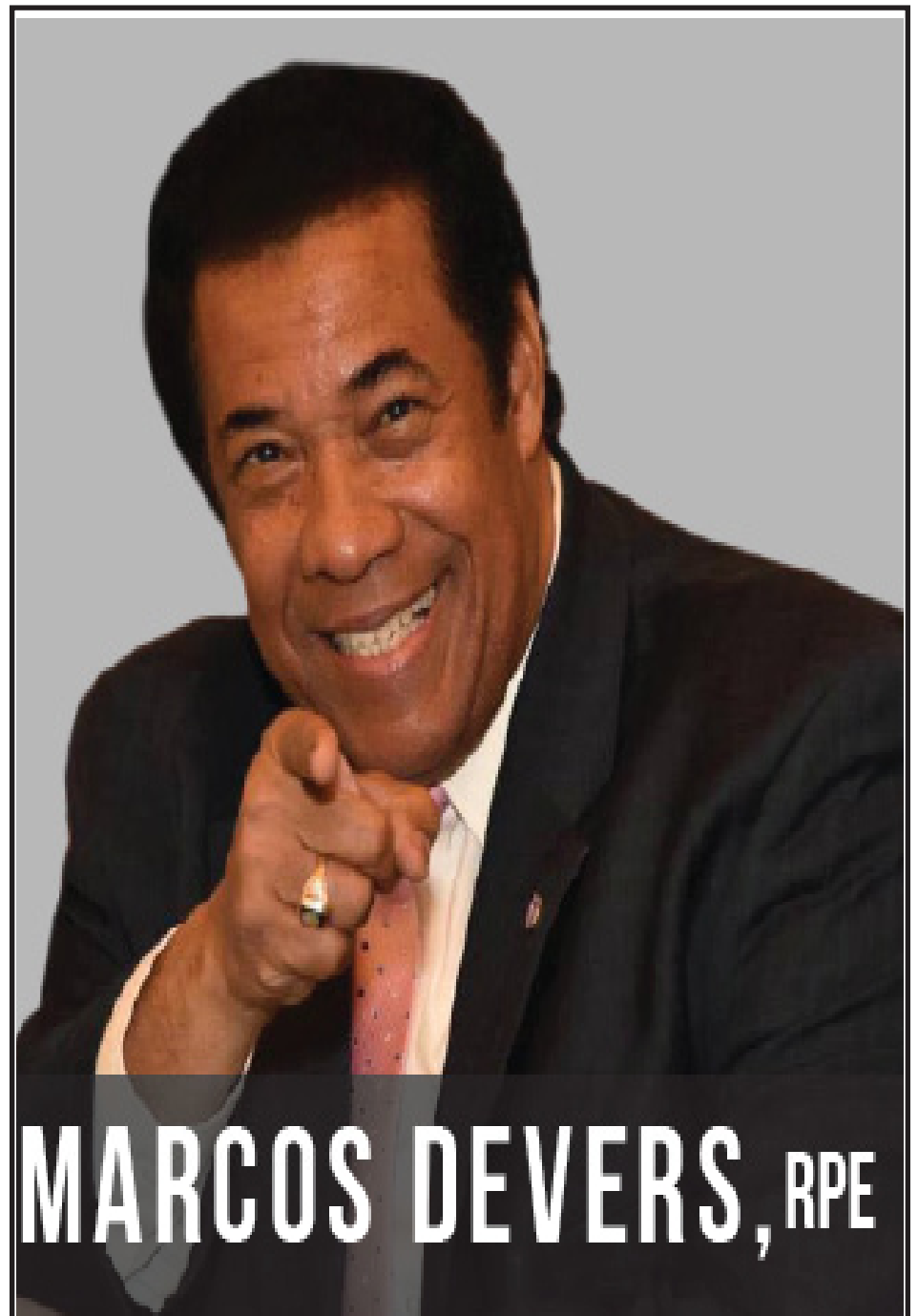
